Territorial changes of municipalities

As a rule, data on the territory of municipalities in Slovenia are changed every four years according to a legally stipulated procedure. Territorial changes of municipalities have been monitored by the Statistical Office of the Republic of Slovenia for several decades since they are important for interpreting statistical data, especially those that cannot be recalculated to the territory of a municipality comparable in time.
