## 1 PURPOSE

The purpose of publishing the data is to show monthly changes in quantities, value and average price of wood purchased from private producers.

Key statistics include:

- The value of purchased wood
- The quantity of purchased wood
- The average price of purchased wood

## 3 UNIT DESCRIBED BY THE PUBLISHED DATA

The unit described by the published data is a wood purchased from private forest owners on the territory of the Republic of Slovenia, shown by use of wood.

## 4 SELECTION OF OBSERVATION UNIT

The survey covers all the major companies that purchase wood from private producers and forest owners.

Covered is a selection of representative companies that purchase wood directly from the forest owners. Some smaller units that are difficult to trace (for the purchase of wood there is no activity code, which would be key for determining the sample) are excluded.

The survey covers about 50 reporting units.

## 5 SOURCES AND METHODS OF DATA COLLECTION

Data are collected monthly.

We collect the data with monthly survey Purchase of Wood (KME-LES/M).

Data are collected with electronic questionnaire:

Questionnaires are available only in Slovene.

The variables in this survey are:

- The value of purchased wood and
- The quantity of purchased wood.

The average prices of purchased wood is calculated on the bases of value and quantity of purchased wood (average unit value).

Data for the survey are not obtained from administrative sources.

## 6 DEFINITIONS

**The value of purchased wood** is calculated from the quantities of purchased wood by purchase price fco forest road. Costs related to the delivery, transport to the warehouse, storage or placing in storage are not included in the value of purchased wood. The price of wood does not include VAT.

**Sawlogs** and veneer logs are used in the production of sawn wood (railway sleepers included) and the production of veneer.

**Pulpwood, round and split:** the entire roundwood (except sawlogs) that will be used for the production of pulp, particleboard or fibreboard.

**Other industrial roundwood:** roundwood that will be used for poles, piling, posts, fences, pitprops, tanning, distillation and matches.

**Fuel wood:** wood in the rough (trunks and branches) that will be used for cooking, heating or power production. It includes wood chips and excludes wood charcoal.

Data are not published by classification.

Data were edited by using appropriate individual corrections.

## **7.3 INDICES**

In First release we publish time indices with moving base. Published index shows change in value of purchased wood, compared with previous month and previous year.

## 9 REVISION OF THE DATA

### 9.1 PUBLISHING OF PRELIMINARY AND FINAL DATA

The monthly data for the current year are provisional. With each First Release the data can be corrected and completed with new data. The monthly data get the status of final data with the publication of annual data (at the latest at the end of February of the following year).

Publishing of provisional and final data is planned. Due to the needs of users for timely information, provisional data are published that meet the criteria of the quality of official statistical data but do not meet the quality that can be met with complete coverage. Data are revised when recent, more complete and better data can significantly contribute to the quality of data-based decision-making.

### 9.2 FACTORS INFLUENCING COMPARABILITY OVER TIME

Data on the purchase of wood, both monthly and annual, have been published since January 2006. In 2006, the categories by which the purchase of wood is monitored were revised, so that data prior to 2006 are not fully comparable with the new categories and consequently not published in the SiStat Database.
